1 YEAR LIMITED WARRANTY

Caputo provides natural stone materials and services designed to last a lifetime. The product you have purchased may be as old as two billion years! Except engineered quartz products, all of **Caputo's** products are 100% made by Mother Nature – no human has had a hand in the creation of any **Caputo** materials; only in their fabrication. **Caputo** merely fashions the already made product into a functional and usable piece of art, designed to last many lifetimes.

Because the materials are completely natural, it is possible that from time to time, naturally occurring defects may be present in stone and engineered quartz materials. It is very important to read this warranty closely so you fully understand what the limits of coverage are. **Caputo** stands behind every product and every project.

All warranties begin from the date of original installation. **Caputo** guarantees that all natural stone materials will be free of defects for a period of one (1) year. **Caputo** guarantees that all installations will be free of defects in workmanship for a period of one (1) year. In the event that **Caputo** determines that there is a defect in the materials or workmanship, **Caputo** will replace or repair the defective product or installation of the failed piece at its absolute discretion. Both materials and workmanship warranties are subject to the following term and conditions.

1. All materials (except quartz products) are naturally formed and subject to a range of natural color variations, characteristics, shading, tensile strength, surface pitting, and fissuring. These characteristics, or imperfections, are not considered defects, as they do not affect the performance of the product. Such defects are not covered by any warranty.
2. Natural quartz surface, specifically CaesarStone, is covered by a manufacturer's warranty. For this product, the **Caputo** one (1) year limited material warranty will be replaced by the manufacturer's warranty. **Caputo's** (1) year workmanship warranty still applies to such products.
3. **Caputo** determines the location of all seams based on the project specifics. The warranty does not cover placement of seam, size of seam, or the materials used to fill the seam.
4. The limited warranty does not cover damage as a result of abuse or misuse by inappropriate cleaning products, chemicals, acid rain or other environmental conditions, food and beverages, or other corrosive, caustic, or other acidic substances.
5. Purchaser must make all claims of defect in writing to **Caputo** as follows:

6. All materials should be maintained in accordance to the guidelines set forth by **Caputo**.
7. This warranty does not cover any expenses incurred during, or associated with any warranty claim. The warranty only covers replacement or repair as stipulated by **Caputo**.
8. Repairs may only be made by **Caputo**, or a **Caputo** provided subcontractor specialist. Repair by anyone other than **Caputo** will void both Material and Workmanship warranties.
9. The warranty does not cover any damage to materials as caused by cabinet settlement, house settlement, or other structural shifts or changes. Seam separation, shifting, or displacement is not covered as well.
10. The warranty does not cover damage, in whole or in part, caused by vandalism, accidental impact, excessive stress or loading, fire, acts of God, structural (architectural) design flaws, or other extraordinary circumstances not related to the material or installation.
11. No other warranties are expressed or implied.
